FREEDOM OF INFORMATION ACT

DU-COMM is a unit of local government formed under the Intergovernmental Cooperation Act (5 ILCS 220) by its member municipalities and Fire districts. DU-COMM is a 9-1-1 PSAP responsible for radio communications and dispatch of police, fire, and Emergency Medical Service (EMS) for forty-four (44) member agencies. DU-COMM's annual budget is approximately 16.9 million dollars. DU-COMM employs approximately one-hundred-ten (110) full-time employees and five (5) part-time employees. DU-COMM has a Board of Directors comprised of officials from member agencies, an Executive Committee; comprised of Board of Directors members and Police and Fire Chiefs, and Operations Committees, consisting of public safety personnel from member agencies.

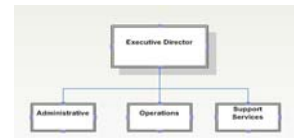

DU-COMM may charge a fee of fifteen (.15) cents after fifty (50) black and white copies. For color copies, DU-COMM may charge a fee of (.08) cents per page. DU-COMM may charge a fee for other requested media forms, as follows: \$.25 per CD-R - \$.57 per DVD-R. DU-COMM may charge requester the cost associated with blank media, not listed here.
